- After submitting the form, you will be taken through the steps to make the online payment.
- Your application will be considered complete only after your payment has been received at NICR end.

- Webcam (Enabled).Webcam may be internal or may be external and connected to the computer.
- Internet Connection. (1Mbps or Above)
- Browser Settings- Enable internet cookies and disable any pop-up blocking setting.
- Firewalls- The Company/corporate firewalls (including VPNs) may cause the issue for appearing in the examination. We suggest candidates to take the examination in a setting without corporate firewall.

- 4. **How to mark a question for review:** If you want to review any question later, you have to click the "Review" checkbox. This answer will be marked for review.

 - c) White Colour: Un-attempted Question.
 - d) Blue Colour: Attempted and Reviewed Question.
 - e) Violet Colour: Un-attempted and Reviewed Question

NICR Online ExaminationPolicy & Instructions with Terms and Conditions

- 1. The online examination is proctored.
- 2. The proctored examination is a timed
- 3. Candidate can take examinationat their convenience. The selected place should be in a walled room, with a closed door and without distractions.
- 4. Once the examination begins candidate should not leave the room or move out of the view of the webcam
- 5. No retake and rescheduling is allowed once the candidate starts the assessment/examination and it will result in forfeiture of examination fee.
- 6. The test-taker must remain alone until the end of the examination and is not allowed to leave the examination.
- 7. No other person is allowed to enter the room while the learner/candidate is taking the proctored examination. If a third party enters the room during the testing process, your examination will be terminated and considered as null and void.
- 8. During the examination, no assistance from other individuals is allowed, you are also not allowed to share the computer screen with other individuals.
- 9. The candidate also agrees not to save a digital copy of the questions of the examination, not to share information about the content of the examination through any communication method, until the publication of the result.
